1. Welcome and Call to Order

Jill Edwards welcomed all the board members and called the meeting to order at 6:37pm.

2. Approval of Agenda

5. Ongoing Business

5.1. Safety Assessment Working Group

This group has nothing new to report. AHS has approved all of our protocols. There
was one positive case with a single swimmer, however, because of our effective
protocols, there were no close contacts.

5.2. Bylaw Review Update

There is nothing new to report.

5.3. AGM Planning

One member suggested moving the AGM permanently to October or November; this
would give us more planning time this year. As well, our finances would be complete
and it would be a natural time to present to members a report on the end of the swim
season. All members were in agreement to move the AGM to a day in the fall - likely
October. Chris will let members know about this decision with a statement in the next
newsletter.

5.4 Club Fundraising/50/50 Raffle Policy

- Chris has tentatively set a Draw Date of June 20, 2021 to co-incide with Father's Day.
- Keyano will use "Rafflebox" a company which runs online raffles. It is the most used in Alberta and nation-wide. Their services and fees were discussed.
- The draw will occur via an AGLC approved Random Number Generator, so no board members will be required to be accountable for the draw.
- There was a discussion regarding the option of having a "Single URL" dedicated solely to EKSC or "Multiple URL's" where each member would share their URL with family and friends. With either option, all proceeds will be going to support the swim club as a whole
- Keyano would design their own URL page.
- Suggested ticket distribution was reviewed and discussed.
- For a \$10,000 raffle, the club will profit \$4,000.
- The amended EKSC Raffle Policy was presented, but there was not time for members to fully review it.
- Members will read over the information regarding the raffle and the policy and Chris will
 include a poll along with the approval for the Raffle Policy prior to the next meeting.

6. New Business

There were no items added to the agenda.

7. Standing Reports

7.1 Head Coach Report

- Group numbers remain steady. Training times and locations are unchanged.
- Coaches and staff feel they are in a perpetual state of limbo anticipating changes in government policy.
- Paul is considering what to plan for summer swimming/training camps.
- There is also uncertainty regarding the school schedule for the fall which then impacts when we can book training times.
- Junior Nationals have been cancelled. There are still about 25 Keyano swimmers interested in travelling to Florida for a five day meet in late July.
- Olympic trials are still scheduled for the end of May, however there is an alternate
 option for June if trials cannot take place in May. There is also the possibility of having
 just top 6 swimmers attend trials.

Swim Alberta has asked EKSC to host Westerns in April 2022. It is a four day meet
which would generate \$12,000-\$15,000 revenue for the club. Members were confident
that we still have enough experienced members in the club who could fill lead roles for
the meet.

7.2 General Manager Report

- CEBA application has been completed and CEWS has been extended to June 5.
- Chris Nelson foresees no major changes following the Charitable Gaming Review.
- Discussion regarding Business Insurance Cyber Coverage will be tabled until next meeting.
- Chris and Paul are still working on the design of Pool Queue (new website).
- Discussion regarding meet scheduling for the fall including CanWest and Candy Cane.
- University of Alberta has committed to agreement for next season
