 Board and coaches background checks: SwimBC and SwimCanada are not interested in reviewing their policy so won't pursue it anymore (as the Board). We have to follow up with SwimBC as they've asked for volunteers' names to complete the process (Board members).

#### Officer Reports

Lisa will remind them specially because they cannot swim until they complete it. There were some issues with some registrations (SwimBC's fault) so Lisa is working to fix it. New coaches have to update their information in poolQ.
- Secretary: nothing to report.
- Head Coach: nothing to report.
- Member At Large: thanks to Lisa for serving on the board:). Poised the question: "Can a previous member not currently registered with the club swim in meets for the club? Treasurer will look into the poolQ system to see if it allows it (as they will be required to be registered in SwimBC).

- Swim caps for swimmers: we have many misprints, some regular. Liz will make inventory and report back. Richard will bring them to the pool to distribute.
