# Follow up from previous meeting

- finalize summer pools
  - update on Second Beach pool and pool in Burnaby for outdoor summer swims Saturday?

    - decision from Vancouver coming up regarding second beach
    - \$1800 budgeted for summer pool
- time trials to set some benchmarks and help encourage meet attendance -> social at Brown's after

  - coaches document with practices on it is on drive (running google doc, most recent practice on first page)
  - will think about how to make practices accessible for those who miss
