#### Officer Reports

- President: Summer outdoor swims lightly attended but better than last year
  - lifeguard charges being investigated
- Vice President: holding for fall registration discussion (9 ppl on summer pause, to be let in winter); 4 ppl on leave that will need to tell us when they're ready
  - o away Sept 3-20
  - have 18 ppl potentially waiting to sign in for the fall (that wanted to wait until Fall)

#### New Business

- 2026 budget
  - looking at proposed budget draft v2
  - o note: 2 tabs, one with guard fees and one without and this adds about \$3000 to budget as well as charges to swimmers
  - o suggesting delaying registration until hear back from pool

- about quard fees
- saved \$\$ on April and outdoor fees and coaching also came in slightly under budget (flat year over year)
- $\circ$  assuming 50 swimmers in Fall/Winter, 45 in Summer, quite a few ppl taking advantage of full year registration discount
- o kept things more in line with 2024 budget than the actuals
- FastSwim morning group is paying more \$\$ for less time (>\$600 for 4.5 hours for FastSwim)
- should we add swimmers? 55? (5 lanes Tues & Thurs and 6 lanes on the weekend) -> VP thinks its palletable; Member at Large says go for it, secretary agrees, Pres seems to agree as well only main concern is lane allocation and empowering coaches to move ppl around as fit
- have worked out multiple scenarios with guard fees, without, with 50 swimmers and with 55 and will wait to register until hear back from Christine
- all in favour of increasing number of swimmers to 55 irrespective of guard fees
- can finalize budget once hear back about coaches & guard fees
- $\circ$  aim for second week of August for registration (Will NOT be August 1)
- 2026 coaches
  - o Anna will be gone
  - o uncertain about Canek
