Review of 2018/2019 Budget vs Updated Forecast Review Bingo Revenues per shift Review 2019/2020 Budget Review 2019/20 Raffle Tickets, Bingos and Fees

As of the end of April, UCSC is projecting a surplus of approximately \$50k for the 2018/19 season. The key contributing factor behind the surplus is an increase in Bingo revenues due to the addition of events at the Five Star Bingo Hall. As highlighted at the Fall AGM, declining Bingo revenues have been a large source of concern from a budgeting perspective. Based on a quick analysis of monthly trends, it is apparent that there isn't an easy button with respect to improving the forecasting process. A surplus of ~\$36k is forecast in the 2019/20 Budget. This forecast surplus together with the forecast surplus in 2018/19 will enable the club to partially replace the \$178k of funds that were taken from the contingency account due to the deficit in 2017/18.

Proposal to increase 2019/20 Fees by 1%, to increase Bingo allocations to accommodate Five Star Bingo events, to keep Raffle Tickets and Balzac Meat fundraising constant for the 2019-2020 term- (refer to presentation material attached)
